4 Governance Issues

(a) General Data Protection Regulation (GDPR):

The Board was indebted to RB for taking on the task of meeting and managing GDPR requirements through the Trust email client, MailChimp. It appeared that only one member had unsubscribed as a result. PL had written to all 34 non-email members and received 9 responses, 6 of whom had supplied email addresses.

(b) Risk Register (RR):

Directors were asked to consider the draft policy relating to the ECC dowry as a priority. In RB's absence RC undertook to coordinate responses.
